Whereas, Judge Ambro then joined Richards, Layton & Finger, practiced there for 24 years, chaired his firm's bankruptcy practice, and became a leading force in Delaware's rise to national bankruptcy prominence;

Whereas, Judge Ambro was nominated to the Third Circuit Court of Appeals by President Clinton on September 28, 1999 and confirmed by the Senate on February 10, 2000;

Whereas, since joining the Third Circuit, Judge Ambro has written over 1,000 opinions, consents, dissents or orders and has sat on panels that have issued over 4,000 decisions or orders;

Whereas, Judge Ambro has written a number of seminal opinions on bankruptcy issues, as well as a variety of decisions of great importance in other areas;

Whereas Judge Ambro has been a Fellow of the American College of Bankruptcy, a member of the American Law Institute, a Conferee of the National Bankruptcy Conference, the Chair of the Section of Business Law of the American Bar Association, a member of the Standing Committee on Federal Judicial Improvements and a member of the ABA Committee on Legal Opinions;

Whereas, in 2015, Judge Ambro received the American Inns of Court A. Sherman Christensen Award, which is bestowed upon a member of an American Inn of Court who has provided distinguished, exceptional and significant leadership to the American Inns of Court movement;
